# MESSAGES FROM PARKS CANADA (APRIL 15, 2024)

#### AIS

Nothing to report on AIS at this time. Once decisions are made for lake use this summer it will be communicated by Parks Canada.

#### WATER AND WASHROOMS IN THE CABIN AREA

Water for individual Cabins and the other operational washrooms (i.e., the same four as last year anticipated to be open when they can be) is anticipated to be on prior to the May long weekend if weather cooperates. Typically, sewer lines remain frozen until that time. Parks Canada will notify the CLCA when the water is on.

#### SHOWER BUILDING

Good News: the Shower Building is open and water testing is complete – drinking water is safe from the Shower Building, including the exterior tap which is on and available.

And thanks to the cooperation between the CLCA President and Wasagaming Townsite Manager, Parks Canada agreed to install coded keypads for the Shower Building. Keys will also continue to work for now or you can alternatively use the code. CLCA members can obtain the codes from the CLCA email address, and non-members can visit the front desk at the administration building with proof of cabin ownership.

## KAYAK/CANOE LAUNCH AREA ("2ND STREET DOCKS")

Construction and archeological work will continue this spring for the pathway and installation of docks. The area will remain closed during construction. Please do not access the area (fencing has been put up around the area). It is anticipated that if all goes well the area should be open and accessible by the end of June. At this time there is no plan to allow kayaks or canoes to be left in that area this season regardless of lake use decisions. We will continue to work with the CLCA on possible solutions for future years (i.e., 2025 and beyond).

If you can't or prefer not to e-transfer, you can drop off your \$10 in cash to your CLCA Treasurer Elvi at her cabin located at 100 First Street South.

#### **AUTOMATED EXTERNAL DEFIBULATOR (AED)**


The Cabin Area has an AED located at the Shower Building. Please report any use of this unit to Parks Canada so we can ensure it is always ready for use.

## WASHROOMS

In accordance with the 2012 Memorandum of Understanding between Parks Canada and the CLCA – and because over 85% of cabins are now connected to water – the intention is still to phase out the public washroom facilities in the Cabin Area over time. Status quo remains in 2024 – washrooms 2, 3, 5, 7 and the Shower Building will be open again this season.



## FIREWOOD FOR COOK SHACKS

A reminder that the firewood that is supplied by the Park is paid for by the Cabin Owners (i.e., cost-recovery). This firewood is ONLY for use by Cabin Owners in the cook shacks. Taking wood to use elsewhere – even by Cabin Owners – is a crime (theft). If you suspect someone is helping themselves for use outside the Park, please don't hesitate to contact Parks Canada and report the incident (with description and vehicle license number if applicable).

## COOK SHACK TOOLS

The CLCA has partnered with Red River College Polytechnic on a student project to produce new sets of quality Cook Shack tools! The CLCA will only be required to pay for the materials used to make the new tools. When ready this summer, the CLCA will make these sets available to Cabin Owners for sale on a cost-recovery basis.

#### FIRE TABLES

Any appliances, such as propane-fueled fire tables and pits, must be CSA approved and used in accordance with the instructions provided and follow <u>FireSmart® principles</u>. For greater clarity, this includes monitoring and maintaining flame height, and never leaving the device unsupervised. Parks Canada continues to monitor and assess the permissibility of these types of appliances.

#### PARKING

A reminder that each Cabin Owner has the use of the 8 feet immediately in front of their lot (between the cabin and the street) as an allotted parking space for 1 vehicle. All other land – including the space immediately behind our cabins – belongs to Parks Canada and can be used for parking on a first come, first served basis. For greater clarity, there's no such thing as a cabin with "2 or 3 parking spaces". However, the CLCA strongly encourages neighbourliness when it comes to parking our vehicles in the Cabin Area, and this would include yielding any space directly behind a cabin to the owner of the cabin, or making the best use of that shared space through an open and cordial dialogue.

#### ONGOING CONVERSATIONS WITH PARKS CANADA

Your CLCA continues to have a strong relationship with Parks Canada. Discussions are ongoing on a number of topics of importance to the membership, including:

- The renewal of the 2<sup>nd</sup> Street docks and the concept of the "lakeshore park area", including the potential for kayak and canoe storage at the 2<sup>nd</sup> Street docks (i.e., "Canoe Graveyard) for CLCA members (note that we're asking that Parks Canada temporarily expand the docks at Fifth Street while access to the 2<sup>nd</sup> Street docks remains closed);
- The completion of the Cabin Area compliance plan and updates to the Cabin Area Building Guidelines (and engagement with the Cabin Owners on the potential changes);
- Vegetation management in the Cabin Area (note that we're looking at planting some trees at the corner of Main Ave and First Street where the old Parks cabin was located);
- Potential renovations to the Shower Building (note that the intent is to add additional washroom facilities);
- Decommissioning of the public washrooms in the Cabin Area (note that washroom no. 6 has now been completely removed);
- Fibre Internet in the Cabin Area (most recent info can be found at <u>this link</u>);
- Vehicle traffic and potential traffic calming measures;
- Repaving of the pathways in the Cabin Area.

For more on these and other issues, please come to our General Meeting on July long weekend, and our Annual General Meeting on September long weekend.
